RESOLUTION NO. 2611

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROLLING HILLS ESTATES, CALIFORNIA, UPDATING THE SCHEDULE OF COMMUNITY DEVELOPMENT DEPARTMENT AND PUBLIC WORKS DEPARTMENT FEES AND CHARGES FOR FISCAL YEAR 2025-26 WITH RESPECT TO FILM PERMIT APPLICATION AND FILMING RELATED FEES.

The City Council of the City of Rolling Hills Estates resolves as follows:

SECTION 1. General Findings. The City Council finds as follows:

A. The City has adopted a Schedule of Community Development Department and Public Works Department Fees and Charges for Fiscal Year 2025-26 (CD/PW Fee Schedule) pursuant to City Council Resolution No. 2606 adopted on June 24, 2025.

B. The City Council has adopted Ordinance No. 755, which adds to the Rolling Hills Estates Municipal Code (RHEMC) a new Chapter 5.62 (Film Permits) establishing a permitting procedure for commercial filming and student filming activities.

C. The City Council desires to amend the CD/PW Fee Schedule to establish new permit application fees for commercial and student film permits as such activities are defined in Chapter 5.62.

D. The proposed commercial film permit application fee is consistent with the fee currently adopted for a special use permit, which was the permit process used prior to the adoption of Chapter 5.62 to review permits for filming activities.

E. The proposed expedited commercial film permit application fee reflects the increased time and required attention necessary to process an application with limited advance notice, and the proposed student film permit application fee reflects only a 25% cost recovery for staff time in light of the educational nature of the activity.

F. The proposed fee for commercial filming on public property is an existing fee currently referred to as "motion picture on public property" and is simply being renamed consistent with the amendments to RHEMC Chapter 5.62 and is being moved to the CD/PW Fee Schedule.

SECTION 2. Adoption of Amendments to the Schedule of Community Development/Public Works Fees and Charges. Based on the findings above and pursuant to Rolling Hills Estates Municipal Code (RHEMC) section 3.04.060, the City Council hereby amends the CD/PW Fee Schedule as follows:

The following permit fees are added:

1.	Commercial Film Permit Application Fee	\$916.00
2.	Expedited Commercial Film Permit Application Fee	\$1,374.00
3.	Student Film Permit Application Fee	\$229.00
4.	Commercial Filming on Public Property	\$1,000.00/day


SECTION 3. The City Clerk is directed certify to the passage of this resolution.
